

SUMMARY REPORT - ESTIMATED MUNICIPAL SOLID WASTE (MSW) RECYCLING & DISPOSAL RATES FOR CONNECTICUT CITIES & TOWNS FY2008

Updated on October 6, 2011 by the Connecticut Department of Environmental Protection Bureau of Materials Management & Compliance Assurance

Please note data qualifiers at the end of this document.

♦ **Recycling data** in this report is based on the FY2008 Annual Municipal Recycling Report Submitted to the Connecticut Department of Environmental Protection by the municipality. Due to a variety of issues, not all towns accurately report the recyclables recovered from their towns. Starting in FY2009 tonnage of bottles, cans, and paper recycled will be based on solid waste facility reports rather than the municipal reports.

♦ **Disposal data** is based on reports submitted to the Connecticut Department of Environmental Protection by CT solid waste transfer stations, resource recovery facilities and landfills.

Any MSW delivered directly to an out-of-state disposal facility or out-of-state transfer station without first going through a CT permitted SW facility would not be included in the data presented below. Therefore, MSW disposal tonnages from those towns or cities would be underestimated.

- Rows with blue shading indicate municipalities with reported MSW per-capita disposal rates less than 600 PPY – which might indicate inaccurate or incomplete reporting of MSW disposed or transferred and consequently might lead to *inflated and inaccurate recycling percentages*. Towns with a double asterisk ** next to their MSW disposal tonnages indicates that some correction was applied to the reported MSW disposal tonnages. However, these towns may still have inaccurate MSW disposal rates and consequently inaccurate recycling rates attributed to them.
- Row with brown shading indicate municipalities with reported MSW per-capita disposal rates greater than 2400 PPY – which seems high and might indicate inaccurate reporting of MSW disposed or transferred. However in many cases, these higher disposal rates can be attributed to demographics i.e. large number of businesses, manufacturers, universities, casinos etc.; influx of summer residents; specific industry generating large amounts of waste, etc. Those towns with a double asterisk ** next to their MSW disposal tonnages indicates that some correction was applied to the reported MSW disposal tonnages.

FY2008 QUALIFIERS FOR DATA USED TO CALCULATE MSW RECYCLED & DISPOSED

Recycling Data Qualifiers:

- ◆ Recycling data is based on the FY2008 Annual Municipal Recycling Reports submitted to the CT DEP.
- ◆ We have found that even though they submit recycling reports to DEP, many municipalities do not report the tonnage of all the materials generated within their town and recycled because those figures are often difficult to obtain.
- ◆ Figures for tonnages of material recycled generally do not include all the non-residential material collected for recycling – such as recyclables backhauled by national retail chains to out-of-state distribution centers for recycling.
- ◆ Tonnages generally do not include glass, metal, and plastic recycled through the bottle deposit law infrastructure.
- ◆ Tonnages do not include: most of the commercially recycled scrap metal, automobile scrap metal, waste oil recycled by businesses or garages, or most of the storage batteries which are recycled through the storage battery deposit infrastructure.
- ◆ The tonnage of leaves recorded as being recycled (composted) at municipal sites is usually estimated on the basis of cubic yards. The reliability of the conversion factor may be affected by the moisture content of the leaves.
- ◆ An attempt is made to estimate tonnages of yard and food waste home composted and tonnages of grass “grasscycled” based on municipal descriptions of their programs to promote these waste reduction strategies.
- ◆ Tonnage of landclearing and demolition material recycled is included in the column “Other Waste Recycled”
- ◆ Tonnages of material reported as “recycled” reflect the amount of MSW reported collected for recycling - not necessarily the amount actually used to make products. Contamination may be disposed at either the recycling processing facility or at the mill or manufacturing facility using the material to make a product and is not subtracted from the tonnages reported recycled by each municipality.

MSW Disposal Data Qualifiers

- ◆ FY2008 MSW disposed for each municipality is based on data submitted to the CT DEP by CT permitted solid waste facilities and is contingent upon the accuracy of reporting by both the facility and the haulers delivering the MSW to the facilities.
- ◆ Data regarding MSW hauled directly out-of-state for disposal is not reported to DEP. Therefore, there may be additional disposal tonnages attributable to some towns.
- ◆ Tonnages of MSW do not always include the tonnage of bulky MSW (furniture, carpets, etc.) which is often reported to DEP as “bulky waste” or “construction and demolition (C&D)” waste.
- ◆ MSW disposal figures represent residential and non-residential disposal.

Comparing Town Recycling Rates

Please keep in mind that it is somewhat misleading to judge the success of a municipality’s recycling program by arbitrarily comparing one town’s recycling rate to that of another town because:

- 1) Recycling potential varies from municipality to municipality and can be affected by the town’s demographics
 - For example – towns with higher per capita incomes tend to generate more newspapers and magazines – which contribute to higher potential recycling rates.
 - Recycling in multi-family dwelling can present greater challenges – but can be successful with the implementation of effective recycling strategies.
- 2) The city or town of origin of MSW reported disposed or recycled by Connecticut SW facilities is not always accurate or complete on a town-by-town basis.
 - Since the recycling percentage for a city or town is based on both the MSW disposal rate and the MSW recycling rate, inaccurate municipal MSW disposal rates and/or recycling rates will result in inaccurate municipal recycling percentages.

The above qualifiers need to be considered when trying to compare one town’s recycling percentage or rate to that of another town.
